THE NAGGING QUESTION

WITH THE VOLUME OF AVAILABLE INFORMATION AND RESEARCH FINDINGS ABOUT THE REMAINING TASK OF EVANGELIZATION OF THE WORLD TODAY,

WHY ARE THERE STILL MANY UNENGAGED,
UNEVANGELIZED, UNREACHED, LEAST-REACHED, UNCHURCHED, UN-TARGETTED, UN-DISCIPLED, UNCLAIMED, UN-OCCUPIED, ETC, PEOPLES, LANDS,
TERRITORIES, ETC, AS WELL AS, INDIVIDUALS WHO
HAVE NOT HAD A WITNESS OF THE GOSPEL TODAY?

THE REASONS ADVANCED FOR THE RESEARCH ACTIVITIES IN JUDGES 18:1-31 STRIKE A VERY CLEAR CORRELATION WITH THOSE OF JOSHUA 18:1-28 AS WELL AS UNDERSCORE THE PURPOSES FOR SUCH RESEARCH ACTIVITIES

REASON

"BUT THERE WERE STILL SEVEN ISRAELITE TRIBES WHO

HAD NOT YET RECEIVED THEIR INHERITANCE"

(Joshua 18:2 NIV)

PURPOSE

"HOW LONG WILL YOU WAIT BEFORE YOU

BEGIN TO TAKE POSSESSION OF THE LAND

THAT THE LORD, THE GOD OF YOUR FATHER, HAS GIVEN YOU.....

GO AND MAKE A SURVEY OF THE LAND AND WRITE THE DESCRIPTION
OF ITAND | WILL

CAST LOTS FOR YOU

HERE AT SHILOH IN THE PRESENCE OF THE LORD"

(JOSHUA 18:3; 8)

REASON

"....the tribe of the **Danites was seeking a**place of their own where they might settle,
because

they had not yet come into an inheritance among the tribes of Israel" (Judges 18:1 NIV).

PURPOSE

"Come on, let's attack them, we have seen that the land is very good. <u>Aren't you going to do something? Don't hesitate to go there and take it over</u>....A spacious land that <u>God has put into your hands</u>..."

(Judges 18:9-10)

RESEARCH MUST RESULT IN SOME URGENT ACTION

<u>POSSESSION</u>: State of having, owning, or controlling something; a TERRITORY OR COUNTRY CONTROLLED OR OWNED BY ANOTHER

THROUGH

ACQUISITION - Act of **GAINING Possession**

ADOPTION – Act of taking something on **AS YOUR OWN**

ALLOTMENT /ALLOCATION – The act of <u>DIVIDING AND GIVING OUT</u>
SOMETHING for a special reason or to particular people

RESEARCH MUST RESULT IN SOME URGENT ACTION

POSSESSION: State of having, owning, or controlling something; a **TERRITORY OR COUNTRY CONTROLLED OR OWNED BY ANOTHER**

THROUGH

APPROPRIATION - A DELIBERATE ACT OF ACQUISITION OF SOMETHING often without permission of the owner

INHERITANCE – The <u>ACT OF INHERITING PROPERTY</u>; act of **ACQUISITION OF A POSSESSION**

The "Discerners & Discoverers" are in a better position to lead the way, guide actions, and determine best strategies of solving the problems they have observed, or appropriating the opportunities they have highlighted

I CHRONICLES 12:32 – MEN OF ISSACHAR

THE LEAST IN NUMBER BUT HAD MORE STRATEGIC ROLE

"UNDERSTOOD THE TIMES AND KNEW WHAT ISRAEL SHOULD DO"

"Issachar is a rawboned donkey, lying down between two burdens;

He saw that rest was good, and that the land was pleasant; (but)

HE BOWED HIS SHOULDER TO BEAR A BURDEN,

and became a band of slaves"

Genesis 49:14-15).

JOSHUA 2:17-21, 23-24; 6:22-23 – THE 2 SPIES

HAD THE PRIVILEGE OF DISCOVERING WHAT THE LORD HAD ALREADY DONE BEFORE THE ISRAELITES APPROACHED JERICHO, RECOMMENDED MEANS OF SALVATION FOR RAHAB'S HOUSEHOLD, AND WERE INVOLVED IN RESCUING RAHAB AND HER FAMILY

JOSHUA 18: 4,6,8-9 – 3 MEN FROM EACH TRIBE

MADE A SURVEY OF THE LAND, DID THE ANALYSIS OF THEIR FINDINGS AND DIVIDED SAME INTO SEVEN PARTS WHICH FACILITATED THE EASY ALLOCATION (DISTRIBUTION) OF THE LAND BY JOSHUA TO THE SEVEN REMAINING TRIBES OF ISRAEL WHO WERE YET TO GET THEIR OWN INHERITANCE

JUDGES 18:8-10; 14-15

INSPIRED AND URGED IMMEDIATE ACTION TO POSSESS

'A SPACIOUS LAND THAT GOD HAS PUT INTO YOUR HANDS, A LAND THAT LACKS NOTHING WHATEVER',

AS WELL AS DIRECTING THE PROCESS OF ACQUIRING OF MICAH'S POSSESSIONS
